Mr. Trevor Jones reported on the following:

- Activity Center update We had \$15,000 in change orders but because Graber Post ran behind schedule, they waived the fee. So in turn, we used that money to add concrete out in front of the building and to fix some drainage issues on the side of the building. The building is now being used.
- Elementary Elevator update Otis Elevator gave us a quote for installing a platform lift for the stairway. The quote is for \$38,868. After some discussion, the Board tabled this issue until they can look into it and make sure that the lift will fit all our needs.

- The new salt storage building and the new archery storage buildings are now completed at a cost of \$7352 and \$2875, respectively.
- There is a meeting on March 30, 2016 to finalize our new College Credit
 Academy. Students will be able to receive an associate's degree in general
 studies through Ivy Tech. IUS is also signing on for the 2017-18 school year.
 With an associate's degree, the student will be able to transfer to other colleges
 upon graduation.
- The annual ISBA Spring Regional meeting will be held on April 16, 2016 at 6:00 at The Pines in Seymour, IN.
