LAWN SERVICE CONTRACT

Upon a motion made by Mrs. Burress, seconded by Mr. Stockdale, the Board voted, 3-0, and the motion carried to approve Cloud's Lawn Care for mowing, trimming and edging of all Southwestern Schools campus grounds, including baseball and softball fields. This is a 3 year contract. Payment will be \$650 per week for approximately 30 weeks from March through October each year. Spraying, weed control and fertilizing of the baseball and softball fields and the track will be done 4 times a year at a cost of \$705 per treatment. This Contract will remain in effect through the calendar year 2019.

SUMMER SCHOOL DRIVER'S ED PROGRAM

LED LIGHTING

Mr. T. Jones discussed changing all our indoor lighting to LED lighting. We should save \$60,000 per year on our electricity bills by changing to LED lighting. We have three quotes: Sustainable Efficiency for \$222,916, Echo Engineering for \$376,000 and Smart Watt for \$400,000. Mr. T. Jones recommendation is to buy the materials for \$85,000 from Sustainable Efficiency and have our maintenance department install them as time allows. The money for this project will come from our current loan. Upon a motion made by Mr. Stockdale, seconded by Mrs. Burress, the Board voted, 3-0, and the motion carried to approve Mr. T. Jones recommendation.
