GENERAL INSTRUCTIONS

WHO MAY APPLY

1. Graduating Senior High School Students

All applicants must be citizens of the United States of America on the date the application is filed. Applications must be filed with the Elks Lodge having jurisdiction in the area of the student's legal residence. Definition of an Eligible Program shall be comparable to that contained in the federal vocational legislation. It is defined as a two year or less vocational/technical program, culminating in an Associate Degree, Diploma, or Certificate, but less than a Baccalaureate Program (Bachelor's Degree). Do not apply if you are planning to pursue an Associate Degree course which is a stepping stone to a 4-year Bachelor's profession.

Vocational Grants Expire 17 months from date of Awards end on October 1 of year following notification unless applied as described below and are subject to cancellation or withdrawal if student's conduct is proven contrary to the principles of law and order and morality supported by Order of Elks. Enrollment must be verified by the college/training school officials, at which time a check in the amount of the award will be forwarded to the school to establish a credit for the student.

BROCHURE PREPARATION AND REQUIREMENTS

1. Applications must be the original or photocopy of the Indiana State Elks Association application which has been dated and signed by the applicant and Lodge official. Type written applications are preferred over hand written submissions, and must be signed in all instances. Applications and all supporting documents must be in English.

2. Exhibits: Should be neat and concise and in chronological order. Letters of endorsement, etc. should be removed from envelopes and bound flat (allowing sufficient margin on left border for readability).

3. Order of Exhibits

a. Completed Application

b. Statement by the applicant must not exceed 200 words, summarizing activities, accomplishments, needs and objectives, which the applicant thinks qualifies he or she for the grant.

c. Any additional letters from parents, educators, or community references should not exceed 150 words each.

All letters must be original, on one side on a single sheet of 8 1/2 x 11" paper, and must be signed by the author.

d. High School transcript

e. Any other information which you feel will help judging, your worthiness

f. All applications must be properly bound (stapled) on left side and enclosed in a standard binder or cover. Elaborate folders should not be used. Clear plastic and bulky hard binders are undesirable.

IMPORTANT: Be sure your application is in the hand of the sponsoring Elks Lodge Chairman prior to the deadline date of February 6, 2023
